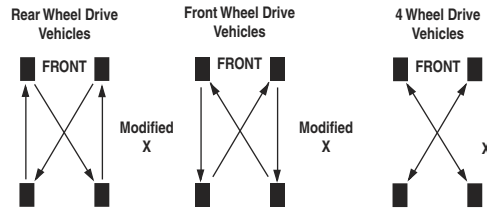

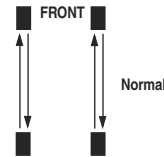

This Nationwide Limited Warranty is made by TBC Corporation and applies only to the tires listed herein that are used within the limitations stated in this booklet.

This warranty makes no claim that your tire will not fail or become unserviceable due to road hazards or any other cause.

Continued driving on any tire containing a puncturing object may lead to tire failure. Check your tires frequently. Remove any foreign objects from the tread and have necessary repairs made immediately. Always check and adjust air pressure every 30 days.

ELIGIBILITY

You are eligible for the benefits of this warranty if you are the original owner of your Cordovan® tire and if the tire has been used only on the vehicle on which it was originally installed. In addition, your tire must have been used according to your vehicle manufacturer's recommendations, in non-commercial passenger car, light truck or sport utility vehicle service (including family vans and mini-vans).

This warranty is non-transferable.

TREAD LIFE WARRANTY

PASSENGER & P-METRIC LIGHT TRUCK TIRES

The tread life of your Cordovan® tire is warranted for the stated miles or months, whichever comes first. If your tire fails to provide you the stated miles or months of service (whichever comes first), you are entitled to an allowance against the purchase price of a comparable new Cordovan® tire or other brand of tire marketed by TBC Corporation. The replacement allowance will be based upon the actual mileage delivered by the tire.

PASSENGER & P-METRIC LIGHT TRUCK TIRES QUALIFICATION

To qualify for this tread life warranty, your tire must have been rotated every 5,000 to 6,000 miles in accordance with the prescribed rotation patterns set forth in this booklet. When you present your tire for a claim, you must be able to demonstrate that this rotation schedule has been maintained. For your convenience, a rotation record is provided in this booklet.

WORKMANSHIP AND MATERIAL WARRANTY

(Only applies to tires listed on the front cover of this form.)

FREE REPLACEMENT FOR THE FIRST 50% OF STATED TREAD LIFE

If your Cordovan® passenger car tire becomes unserviceable due to a defect in workmanship or material during the first 50% of its original tread life (first 2/32 inch of tread life on light truck tires), the tire will be replaced at no charge to you with a comparable new Cordovan® tire or other brand of tire marketed by TBC Corporation. Mounting and balancing will also be provided at no charge. If proof of purchase date is not provided, the duration of coverage for the free replacement period will be based on the date of manufacture of the tire. Claims for ride disturbance will be adjusted during the first 2/32 inch of original tread depth only.

PRORATED ADJUSTMENT FOR THE REMAINDER OF ORIGINAL USABLE TREAD LIFE

If your Cordovan® passenger tire becomes unserviceable due to a defect in workmanship or materials during the last 50% of the original usable tread life (after the first 2/32 inch of tread life on light truck tires), you are entitled to an allowance against the actual regular retail selling price at the time of adjustment of a comparable new Cordovan® tire or other brand of tire marketed by TBC Corporation. The replacement allowance will be equal to the percentage of the remaining tread depth of your tire. You must pay for mounting and balancing the replacement tire, as well as all applicable taxes.

TREAD MEASUREMENT

Tread life and treadwear are measured by the depth of the remaining tread on a tire. A tire has delivered its full original tread life when it is worn down to the last 2/32 inch of tread. Treadwear safety indicators molded into the tire will appear on the tire when that point of wear is reached which indicates that the tires must be replaced. Failure to replace tires may result in loss of vehicle control and serious injury.

LIMITATIONS

These warranties are applicable only in the United States. These warranties do not cover, and no adjustment will be made for:

- Tires improperly repaired or with repairs not conforming to Rubber Manufacturers Association standards, or with section repairs, or with self-vulcanizing plug only.
- Tires used in commercial applications on pickup trucks, campers, recreational vehicles, or stretch limousines (including taxi cabs, police cars, and emergency vehicles).
- Road hazard damage.
- Tire conditions resulting from improper mounting procedures (including broken beads), improper inflation, overloading, mechanical condition of the vehicle, racing, fire, theft, vandalism, collision damage, or other tire neglect or mistreatment.
- Ride disturbance after the first 2/32 inch of original treadwear.
- Ozone or weather checking on tires over four years from the date of manufacture or proof of purchase.
- Tire conditions resulting from intentional tire alteration, such as the addition of white sidewall inlay or balancing or sealing materials.
- Personal injury or property damage, including injury and damage arising from failure to observe the safety information listed below or other circumstances beyond TBC's control.
- Tires submitted for treadwear adjustment without a copy of the rotation record and proof of purchase.
- **Loss of time, inconvenience, loss of use of your vehicle, or incidental or consequential damages.**

Some states do not allow the exclusion or limitation of incidental or consequential damages, so this limitation or exclusion may not apply to you.

No express warranty is given other than as stated herein. No implied warranty of merchantability, fitness for a particular purpose, or otherwise, is given on tires used on pickup trucks, campers, recreational vehicles, or stretch limousines, or in commercial applications.

OWNER'S OBLIGATIONS

A. It is your obligation to present the tire for which you are seeking an adjustment to the dealer from whom the tire was purchased. Should this, for any reason, not be possible, you may take it to the nearest Cordovan® dealer. Please consult the telephone directory for locations. To assist you in locating the nearest Cordovan® dealer, you may telephone TBC Corporation toll-free DURING NORMAL BUSINESS HOURS: (800) 238-6469.

B. You are responsible for payment of any additional parts or services ordered (including alignment). Any charges for the required 5,000 to 6,000 mile interval tire rotation are at the dealer's discretion.

C. No claim will be recognized unless accompanied by proof of purchase, your identification as the original purchaser, identification of the vehicle on which your tire was originally installed and, in the case of a claim under the Tread Life Warranty, evidence that the prescribed tire rotation schedule has been maintained. If proof of purchase date is not provided, the duration of coverage, where applicable, will be based on the date of manufacture of the tire.

LEGAL RIGHTS

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

IMPORTANT SAFETY WARNINGS

Serious injury may result from:

- Tire failure due to under inflation/overloading. (Follow owners manual or tire placard in vehicle.)
- Explosion of tire/rim assembly due to improper mounting. (Only specially trained persons should mount tires.)
- Failure to match the tire's bead diameter with the rim's bead seat diameter. (Example: a 15 inch tire must always be mounted on a 15 inch wheel or rim.)

These recommendations can save you money and reduce the risk of tire failure.

1. Check tire inflation pressures frequently (at least every 30 days). Always check pressures when tires are cool and maintain the pressure recommended by the vehicle manufacturer.
2. Check your tires frequently for injuries such as cuts, abrasions, and impacts. If you detect any foreign objects in the tread or suspect impact damage, have the tire inspected and repaired, if necessary, by an authorized dealer.
3. Avoid running over debris (such as glass or metal) or potholes, which could damage the tire.
4. Never overload your tires. The maximum load and inflation pressure of the tire is molded into its sidewall. Remember—only inflate tires to maximum air pressure if your tires are carrying the maximum load.
5. If your vehicle is stuck in snow, mud, sand or a physical barrier such as a ditch, avoid excessive tires spinning. Never exceed 35 mph on the speedometer when spinning your wheels; the centrifugal force generated above that speed could result in a sudden tire explosion and possible injury. Use a gentle backward and forward rocking motion to free the vehicle.
6. Never mount radial ply tires on the same axle as non-radial tires. Never mount radial tires on the front axle when non-radial tires are mounted on the rear axle. These conditions could create vehicle instability resulting in a sudden loss of control and serious injury.
7. Never drive on tires with less than 2/32 inch of remaining tread. Replace tires as soon as the treadwear indicators become visible in the tread. These will appear as a solid bar across the tread—they will indicate that 2/32 inch or less of tread depth remain. Failure to replace tires may result in loss of vehicle control and serious injury.
8. Never operate your vehicle in excess of lawful speeds or the maximum speeds justified by driving conditions. With proper care and handling, you Cordovan® tire will give your vehicle a smooth ride—with quiet ease and control.

TIRE REGISTRATION

Purchasers of automobile tires will receive a tire registration form from your tire dealer at the time you purchase your tires. You are encouraged to complete this form and return it to the address on the registration. This will ensure you to be contacted in the event of a product recall.
