



All Steel Radial Truck Tire MANUFACTURER'S LIMITED WARRANTY

WHO IS ELIGIBLE?

YOU ARE ELIGIBLE FOR THE BENEFITS OF THIS WARRANTY IF:

- You are the owner of new Triangle® medium radial truck tires, and
- Your tires bear Department of Transportation-prescribed tire identification numbers and are not branded "NA" (Not Adjustable), or "Blem" (Blemish) and
- Your Triangle® truck tires have been used only on the vehicle on which they were originally installed according to the vehicle manufacturer's or tire manufacturer's recommendations, and
- Your tires were purchased on or after June 1, 2004.

WHAT IS COVERED AND FOR HOW LONG?

FREE TIRE REPLACEMENT

Triangle® truck tires covered by this warranty that become unserviceable due to a defect in workmanship or material during the first 2/32nds of usable treadwear or 12 months from date of purchase, whichever comes first, will be replaced with a comparable new Triangle® tire without charge. You pay only for the mounting and balancing. (Without proof of purchase, date of manufacture will be used to determine age.)

PRORATED TIRE REPLACEMENT

Tires worn beyond the first 2/32nds of usable tread, or are more than 12 months from date of purchase, whichever comes first, that become unserviceable due to a defect in workmanship or material will be replaced on a prorated basis. You are responsible for mounting and balancing charges.

HOW WILL PRORATED CHARGES BE CALCULATED?

The replacement price will be calculated by multiplying the current Triangle® original tread that has been worn off at the time of adjustment. The cost of mounting, balancing, and other service charges, disposal fees, or applicable taxes are payable by you.

WHAT IS A COMPARABLE TIRE?

A "comparable" new Triangle® tire may either be the same line of tire or, in the event that the tire is not available, a tire of the same basic construction and quality with a different sidewall or tread design. If a higher-priced tire is accepted as replacement, the difference in price will be at an additional charge to you. Any replacement tire provided pursuant to this warranty will be covered by the Triangle® radial truck tire warranty in effect at the time of replacement.

WHAT IS NOT COVERED BY THIS WARRANTY?

1. Tires branded or marked "Non-adjustable (N/A)", or "Blemished (Blem)", or previously adjusted.
2. Irregular wear or tire damage due to:
 - a) Road Hazards (including punctures, cuts, snags, impact breaks, etc.).
 - b) Wreck, collision, fire, or vandalism.
 - c) Improper inflation, overloading, misapplication, misuse, negligence, high-speed tire spinning, chain damage, improper mounting or demounting.
 - d) Mechanical condition of the vehicle, including misalignment, wheel imbalance, faulty shocks or brakes.
3. Ride disturbance after the first 2/32" of treadwear or due to damaged wheels or any vehicle condition.
4. Ozone or weather cracking on tires over four (4) years from the date of manufacture.
5. Alteration of the tire or addition of alien material or transfer from one vehicle to another.

6. Loss of time or use inconvenience, or any incidental or consequential damages.
7. Tire use outside Continental United States.

WHAT IS THE RADIAL CASING WARRANTY?

A. Casing of Triangle® radial truck tires are warranted when tire becomes unserviceable or unretreaded due to factors within manufacturer's condition, TBC Corporation will provide predetermined casing allowance.

B. Casing warranty is valid during the 2nd retreaded life or for three (3) years from the date of manufacture, whichever comes first.

C. Tires used in mining & logging service are not covered under this warranty.

D. Casing & retreading allowance are as follows:

WHEN DOES THE WARRANTY END?

A tire has delivered its full original treadlife and the new tire coverage of this warranty ends when the treadwear indicators become visible, or four (4) years from the date of original tire manufacture or new tire purchase date (without proof of purchase, date of manufacture will be used to determine age.) Casings may continue to be warranted beyond the new tire coverage. Please refer to the Radial Casing Warranty for warranty details on casings.

HOW DO YOU OBTAIN AN ADJUSTMENT?

In order to be eligible for Triangle® Limited Warranty service, the owner must:

- A. Present the adjusted tire to an authorized Triangle® retailer; and
- B. Present proof of purchase (if applicable) to faction of the retailer;
- C. Complete and sign a Triangle® Warranty Claim Form, which is available at any authorized dealer; and
- D. Pay the amount due on a new tire, less the amount of credit, including taxes, mounting and balancing charges or cost of other services ordered.
